PROPOSAL FOR ESTABLISHMENT OF THE ASRC FINANCE COMMITTEE

Submitted for Consideration by ASRC General Membership December 7, 1985

Presented herein is a proposal to establish an ASRC Finance Committee, that will conduct its business at the Conference level with the oversight of the ASRC Board of Directors. The proposed functions of the Finance Committee are as follows:

- Coordinate ASRC Group-submitted "wish-lists", requests for donations, equipment requirements, etc., and prioritize Conference responses to such requests.
- Review, consider and enter into negotiations with external agents for the acquisition of donations of goods, materials, services and money.
- Recruit, for the ASRC, expertise in the conduct of Conference ence financial business. Included may be individuals knowledgable in fund-raising, tax law, accounting, banking, contracts, investments and financial planning.

 Tracts, investments and financial planning.
 - o Prepare and manage call Conference correspondence related to solicitations and inquiries concerning donations, as well as all correspondence acknowledging receipt of same.
 - Frovide contractual oversight for business agreements, with external agents. For example, grant awards usually require that the grantee perform some service for the grantor over some specified period of time. The Finance Committee would be responsible for seeing that contractual obligations on both sides are indeed met.
 - Conduct short- and long-range financial planning for the ASRC, as requested and directed by the Board of Directors.
 - o Recommend, to the ASRC Operations Committee, SOPs for those missions requiring an ICS Finances Section.
 - Conduct miscellancous finance-related projects, e.g., surplus administration, finding better Group insurance coverage, dealing with Fatagonia, etc.

Recognizing that a Committee, having the functions described above, embodies a tremendous amount of power, certain checks and balances go hand-in-hand with its operations. The following guidelines are proposed to help guarantee the professional conduct of Finance Committee business:

- o The ASRC Treasurer shall appoint a Corporate Financial Officer (CFO) to chair the Finance Committee. This appointment must be confirmed by a majority vote of the ASRC Board of Directors. Such confirmation shall grant to the CFO the privileges of acting in that capacity for the ASRC as a whole.
 - The ASRC Treasurer will be a voting member of the Finance Committee and will act as liason from the ASRC Board of Directors to the Finance Committee, and vice versa.
 - All members of the Finance Committee must be at least Associate members in the ASRC. Finance Committee members will be recruited and selected by the CFO, but must be confirmed by a majority vote of the Board of Directors.
 - o Although the Finance Committee will be empowered to enter into negotiations with outside agents, for the donations of goods, materials, services and monies, the Board of Directors shall have final authority to commit the Conference to formal agreements, contracts, etc.
 - The Finance Committee shall be charged with keeping written records of all Committee business, as well as maintaining the Corporate Record of all business agreements entered into by the ASRC. All Committee business shall be executed pursuant to requirements of fair business practise under the ASRC Articles of Incorporation and laws of the Commonwealth of Virginia.
 - o The business emphasis of the Finance Committee shall be the procurement of goods, materials, services and monies. Dispersenent of these acquisitions shall remain under the direct control of the Board of Directors.

IT IS MOVED that a Finance Committee, performing the above-stated functions, under the above-stated constraints, be convened. The Finance Committee shall operate as a Conference-level entity until such time that the ASRC Board of Directors elects its dissolution. Dissolution of the Finance Committee shall require a majority vote of the ASRC Board of Directors.

- 28 January 1985. Louisa Co.VA: Overhead team callout for a missing 18 year -old mentally handicapped male. The subjecct walked out 5 min. after ASRC team arrival.
- 7 February 1985. Albermarle Co. VA: Callout aborted before response made.
 29 March 1985. Boutetourt Co. VA. A 26 yr despondent male "highly religious and imaginative" was found by an open sweep search. 31 ASRC personnel contributed 98 man-hours to this multi-agency response.
- 9 April 1985. C & O National Historical Park, MD. Approximately 30 ASRC volunteers participated in a search for a missing male along the canal. No find was made at this time. but later in the year a recovery from the river was effected by local authorities
- 19 April 1985. Louisa and Fluvanna Co., Va. 10 ASRC personnel assisted dog teams and the VA State police in an evidence search. Nothing was found to aid poice in their murder investigation.
- 19-28 April 1985. Warren Co., VA/Shenandoah Nat'l Park. To this search ASRC members contributed 2500 person-hours along with dog handlers, other ground search teams, the CAP, local fire, rescue and law enforcement personnel, the National Park Service, the Salvation Army, the US Army, US Marine Corps and flight crews from the VA State Police.

This was the most extensive search the ASRC has been involved with to date. It covered about 16 square kilometers. The subject was a 66 year female, thought to be evasive and who had been lost in this area twice previously. The operation was managed primarily by ASRC pembers and ended when a local resident found the subject in good health only a few hours re the search was to be suspended.

- 30 July 1985. Lindside, WV An overhead team of 6 ASRC personnel responded to a plane crash that turned out to be a false alarm.
- ? July 1985. Page Co. VA. Overhead team response to a lost person search REPORT NOT YET FILED.
- 9-11 August 1985. Loudon Co. VA Search for a female logger. Foul play suspected. REPORT NOT YET FILED.
- 10. 25 August 1985. Augusta Co. 'VA The ASRC was alerted to a plane crash on Afton Mountain. It was located before any conference resources were requested.
- 11. 26,27 August 1985. Warren Co. VA/Shenandoah National Park. ASRC members responded to stage a medical team for a downed aircraft search. The plane was found (no survivors) in the search areas on 3 September by search dogs.
- 12. 29 August 1985. Albemarle Co. VA Missing person search. REPORT NOT YET FILED.
- 13. 2 September 1985. Frederick Co. VA Alert for a downed aircraft. No response requested.
- 14. 22 September 1985. Albemarle Co., VA Overhead team callout aborted.
- 23-24 September 1985. Augusta, Rockingham Counties, VA/Shenandoan NP. A commuter aircraft crashed while making a missed approach to Shenandoah Valley Airport, killing all fourteen aboard. ASRC members contributed 464 man-hours to the search and recovery operation, which received national media coverage.
- 25 September 1985. Powhatan County, VA. Aborted ovehead team callout to lot person search.
- 17. 2 October 1985. Davidsonville/Anne Arundel Co, MD. Callout for suburban SAR. REPORT NOT FILED.

18. 7 October 1905. Loudon Co., vm. Aborted 1911 Calledt th Load person Search.
19. 77 October 1985. Greensboro NC. Notification of Cave rescue. Complainant was referr to cave rescue teams.

Proposal for Record Keeping

- 1.0 Definitions for Dres Power
- 1.1 ASRC is the Appalachian Search and Rescue Conference as an entity seprate from its member groups.
- 1.2 Board is the Board of Directors of the Appalachina Search and Rescue Confrence.
- 1.3 External Entity (Entities) is any organization (business, government, club, etc...) or individual that is not a member of the Appalachinan Search and Rescue Conference, or who is a member, but, is repesenting another organization at the time.

1.0 Records

- 1.1 The official versions of all ASRC documents (records, meeting minutes, correspondence, agreements, etc...) will be kept a the ASRC Coperate Headquarters.
- 1.2 All correspondence incoming or outgoing, from any ASRC member, in any official capacity, to any External Entity are to be copied and sent to the ASRC Headquarters for filing.

2.0 Agreements

- 2.1 All agreements between the ASRC and any external entity are to be written, and approved by the ASRC Board of Directors prior to the agreement being effective.
- 3.0 Representation of ASRC by individual members
- 3.1 Any member wishing to officially represent the ASRC to any external Organization, or at any event, must first gain the approval of the Board prior to the representation.

Proposal for ASRC Committees and Appointments

- 1.1 The Board shall have the right to create, change, or dissolve and committee or appointment, not specified in the ASRC ByLaws, by a majority vote.
- 1.1 At the creation of a committee or appointment the Board shall approve a mission statement containing the purpose(s) and administration of the committee or appointment. Any evaluation of a committee or appointment shall be based upon its stated purpose(s). A committee or appointment may apply to the Board for a change in it's assigned purpose(s).
- 1.2 Each committee and appointment shall present, in writing, status reports at the April and October Board meetings.
- 1.3 Each committee is required to hold, at least, semiannual meetings. These meetings are to be scheduled, announced at the Board meeting prior to committee meeting.

I feel an operation such as this dramatically illustrates the positive accomplishments which can be achieved through cooperative efforts.



Thank you for your recent letter and kind words. I apologize for the delay in getting back to you but with vacation, the holidays, etc. it couldn't be helped.

It certainly was a pleasure to have met-and worked with the ASRC on the Robertsdale Mission. I believe that the mission went as best as could be expected (given the circumstances) and I certainly may accept your offer of providing assistance on future missions. Don't be overly concerned about the uniform dogma with the "locals", you have to understand the "character" of the area in which the search was held (the locals do not befriend anyone in any uniform).

While on the subject of the Robertsdale Mission, the following information will bring you up to date. A post mission critique was held on December 11, 1985. Attendance and representation from all agencies involved was quite good. Ralph Isett, brother-in-law of the lost person was also present. Discussions ranged from resource usage (or non-usage on Wednesday when we were inundated with searchers) to investigation (we now have the respect of the Pennsylvania State Police in the area and they have assured us better service) to questionably high POD's computed for some sectors. Discussions were good and some suggestions will assist us in future missions; which is the purpose of post mission critiques. Mr. Emerson Carbaugh is currently listed as a missing person by the Pennsylvania State Police and they are performing follow-up criminal investigations. They would not elaborate as far as suspects or direction and progress of the investigation.

I have received the Nov./Dec. issue of the ASRC Newsletter "Appalachian Search" and appreciate your adding my name to the mailing list. I also may take you up on your invitation to write an article for a future issue. I am not long winded so I can keep it to within the recommended length.

As far as joint training sessions in one of our state parks or forests, I think it is a great idea. I will keep you posted as things develop.


Dear Paul:
