OLD BUSINESS

- 1. The ASRC tax exemption application to IRS is pending correction of past several years financial reports.
- 2. There is 6 months remaining in the 18-month extension to the AMRG regular 36-month review. McCabe will follow up with AMRG and provide technical assistance as requested or needed.
- 3. RSAR is due their 36-month review today. They have requested a two-month extension.
 - Σ Motion made, seconded and passed without discussion.
- 4. The 1992 ASRC general membership meeting has been moved to C'ville on April 4. The meeting had been scheduled to be hosted by SMRG. ASRC BOD meeting starts at 1000 and the General Membership meeting is at 1300. Activities related to this include:
 - a. There will be an effort to compile actions and resolutions taken by the BOD during the last year.
 - b. There will be an Incident Staff class on April 5, 1992.
- 5. Awards: At the April 4 Annual Meeting there will be certificates distributed to those with 10 or more years ASRC participation. Certificates will be conservative, yet trendy and contained in individual folders. McCabe will handle this. There was discussion of awarding brass Sierra cups, but this consideration of changed to glitchy certificates. There is a \$200 cap on awards.
- 6. **Pagers:** Greg Shea/SMRG is handling arrangements with Metrocall for a central ASRC contract agreement. Presently, RSAR, SMRG, BRMRG, SWVaMRG and ESAR-616 have an interest in the new pager system.

- Description Motion made, seconded and passed that one person gather information and develop a written report by February 20. Person named was Dawn Arbogast.
- 7. **Grants**: The ASRC is considered as one group when applying for state grants. Therefore all groups must apply as the ASRC together for state grants, in the future. This will call for a coordinator position in the ASRC.
- 8. Year-End Reports are due. BRMRG was the only group submitting their year-end report. (see attachments)

NEW BUSINESS

- 1. ASRC Arrangements with Washington, D.C. legal firm for assistance with 501(c)(3) IRS application: There are a number of questions which need to be resolved. These include: (a) was a contract signed by BB? (b) Did BB advise firm of the ASRC \$500 cap and did BB receive a written confirmation from firm of the \$500 cap? (c) Is any part of the IRS Application form completed? If so, who has? (d) do we owe any money for the work already completed on the specifically assigned task?
- 2. We need to submit a Notice of proposed changes to the ASRC Articles of Incorporation to enable us to file for IRS exemption. (This assumes the IRS application will be submitted before the Articles are formally changed.)
- 3. The BOD needs to thank BB for his work and contributions as the Secretary.
- 4. Camille Birmingham will complete the term of ASRC Secretary.
