### **OFFICER REPORTS:**

### CHAIR:

The Chair reviewed the rules of the meeting. He also introduced his proposal for an updated Operations Manual, which includes proposals for annexes which describe various procedures. A copy was given to each Group.

Gary Mechtel expressed resentment of the manner in which he was relieved of Operations (without prior notice). He requested explanation of comments made at the time and inquired as to the availability of a tape. He also expressed concern that his proposals never received full consideration. The Chair apologized and a consensus was reached that Gary's proposals should be incorporated into the proposed update of the Operations Manual that is being considered by the BOD. Furthermore, Gary will present his ideas at the next BOD meeting.

The Chair also shared some ideas concerning the disaster SAR role of the Conference. He envisioned ASRC personnel staging at an army base and being brought in by helicopter for ground operations in problem areas identified by a previous CAP air sweep. Mark Pennington expressed concern

that until the ASRC is included in the VA disaster plan, it would be difficult to interface with other agencies in a disaster situation. Keith Conover remarked that training for disasters should be kept to a minimum, and several other BOD members voiced agreement.

### **SECRETARY**:

The Secretary apologized for the tardiness of the August minutes. He passed out a corrected version of the first page, which was incorrectly dated as April. A motion to accept the minutes as amended by the Secretary passed.

The filing cabinet was purchased. Search documentation is apparently becoming more voluminous, as the third drawer of four is already half-full with 1992 alone.

Several letters requesting information on training materials/courses were received and forwarded to appropriate personnel.

Keith Conover gave a report on the status of the W-EMT Curriculum Development Project. A written report is attached.

Gary Mechtel requested that a policy be created concerning medical activities at fundraisers, especially across state lines. He also suggested a MOU on interstate medical activities with all our primary states of operation.

The Virginia OMD approved Bob Koester's <u>Outdoor First Aid</u> as medical protocols for the ASRC with three changes. The book is written for the lay public. Inserts will be provided to ASRC members or Groups purchasing the book which cover the required changes.

Keith Conover (OMD for PA) stated that separate protocols for PA will be developed in 1993.

The Surry County search produced at least one case of confirmed Rocky Mt. Spotted Fever and at least one case of confirmed Lyme Disease.

Keith Conover shed more light on the OSHA requirements issue. VA is a "planned" state. The surrounding states are not. In "unplanned states" it has been recommended that the OSHA requirements be treated as though they apply to volunteers until notified otherwise.

### **OLD BUSINESS:**

<u>TAX-EXEMPT STATUS:</u> Bob Koester received final financial statements from the Treasurer today.

FTM TEST: Hopefully will be ready by end of year.

**OPERATIONS MANUAL:** See ASRC Chair report.

### TRAINING MANUAL:

Scott Shuffield feels that most material commercially available is outdated, and buying a large library is not advisable. He will continue with evaluation of a few manuals including the old ASRC manual, the SARTA manual and Cooper's <u>Fundamentals of SAR</u>. Keith Conover stated that he may be able to work on a manual starting in July.

RSAR 36-MONTH REVIEW: Tabled until Dec. meeting.

### ANNUAL MEETING REQUIREMENTS OF SCC:

Bob Koester reported that the requirements have been met.

### **BYLAW CHANGE:**

The letters sent out by Dave Carter concerning the bylaw change failed to produce a sufficient response without relying on the idea of counting a lack of response as a positive vote. Bob Koester questioned the legality of that method of counting votes, as it produced no written record of sufficient votes to pass the motion. He also suggested that the change to the bylaws could be better worded.

It was decided to try again, using a different method to encourage voting. Bob Koester and Keith Conover drafted new wording for the amendment, AS FOLLOWS:

Resolved, that the Board send a mail ballot, with a cover letter describing the need for a re-vote, including an ASRC-addressed, stamped post card, to all Active Members, with the following motion:

Resolved, that the Article V (Amendments) of the ASRC Bylaws be revised as follows:

Delete current Section 2. Replace with a new Section 2: "The proposed amendment shall be adopted upon receiving more than two-thirds of the votes entitled to be cast by members present or represented by proxy at the meeting."

Add a new Section 3: "Written notice stating the place, day, and hour of the meeting where Bylaw amendments shall be considered shall be delivered, either personally or by mail, to each Active Member, not less than twenty-five nor more than fifty days before the date of the meeting. The specific proposed amendments need not be included in this notice."

The Secretary will be responsible for assembling and mailing the ballots and letters, as soon as the Chair provides him with mailing labels and the letter, and Keith Conover provides him with the postcard ballots.

### NEW BUSINESS:

### **PROMOTIONS:**

Jenny Burmester, SMRG GTO, made a motion that Paul DeHaven be promoted to Incident Staff, having met all the requirements. The motion passed.

Bob Koester, acting for the BRMRG GTO, proposed that Camille Birmingham, Patrick Turner and Greg Perron be promoted to Incident Staff. It was determined that they met all the requirements. A motion to vote on all three candidates together passed, and a motion to promote all three candidates as proposed passed.

Bob Koester also proposed that Bruce Hemmer be promoted to Incident Commander. It was determined that he met all the requirements, the required letters of support were read, and a motion to promote the candidate as proposed passed.

### ASRC BUSINESS CARDS:

A motion passed to buy 1000 ASRC business cards (without names of individuals printed on them) to be distributed to the Groups. These would be primarily intended for inclusion in ops kits. The Treasurer will establish a printer, who will be authorized to print further cards for individuals on the ASRC roster, at the individual's expense, with the individual's name printed on the cards. The only titles permitted will be medical certifications (EMT and above) and educational degrees (such as PhD). The cards will use the DES EOC phone number for an emergency contact number.

#### **ASRC INK-PENS:**

A long time ago, the BOD expressed interest in purchasing pens with an ASRC logo on them for PR purposes. An auxiliary benefit would be that pens with an alternate color scheme could also be printed which would be assigned to ops kits only, as a way of cutting down on attrition of ops kit pens. David Carter will investigate the cost involved and report at the next BOD meeting.

#### **MINUTES:**

To reduce the cost of producing and mailing the minutes, it was decided that including material other than routine reports in the distributed minutes will be required only if the Secretary is specifically requested to do so. Whether appointed officers (as opposed to elected officers) should be referred to as "Officers," "Committee Chairs" or some other title will be evaluated by the ASRC Chair.

### **STORAGE:**

The Treasurer will investigate the cost of a storage facility for ASRC archives.

### **CONFERENCE SAFETY OFFICER:**

A motion passed as follows:

Resolved, that the ASRC Chairman appoint, on a continuing basis, a Conference Safety Officer. The duties of the Conference Safety Officer shall be:

1. to investigate all accidents, injuries, illness, and "near-misses" that occur on ASRC or Group training sessions, simulations, or missions, and

2. to make recommendations to the ASRC Board regarding such incidents.

The Chair appointed Gary Mechtel to the position, and he accepted the appointment. Ensuing discussion suggested that demonstrating such concern and prudence may make it easier to get insurance coverage if we ever decide to do so. The possibility of also having Group Safety Officers was discussed.

### **ALERT/DISPATCH:**

Camille Birmingham, the BRMRG Alert/Dispatch Coordinator, made a proposal concerning what the qualifications for ASRC AO's should be. A copy is attached. The proposal was tabled to the December meeting, when Gary Mechtel will make a presentation of his proposals concerning the alert/dispatch structure.

Camille also presented the attached form for collecting information on each IS, IC and Tracker in the Conference for Conference Dispatch purposes.

Dave Carter asked Camille to provide each Group with current information on how dispatch works. She will give a presentation at the next meeting.

Reports of any problems with Dispatch should go to Camille. There was a problem with the pager net in the DC area on a recent search - it was Metrocall's fault. It is important to respond to pager tests so that these problems can be detected!

### 1-800-800-ASRC:

The Treasurer will again investigate the feasibility of the ASRC taking over financial responsibility for the above toll-free #, so that it can be used by all ASRC members during missions. USE IS CURRENTLY RESTRICTED to BRMRG members and staff at Base. The issue has been raised again because EOC no longer wants individuals enroute to a mission using the EOC toll-free number to make sure the search is still in progress.

### ASTM PROPOSED STANDARD SAR TERMINOLOGY:

William Dixon, the ASRC Representative to ASTM, presented the attached list of standard SAR terminology that ASTM has proposed. He asked for input by 20 Oct 92.

William wishes to **RESIGN as ASTM Representative**. Anyone wishing to replace him should speak to him or the ASRC Chair as soon as possible.

### DOG HANDLERS' CONCERNS:

William Dixon mentioned that members of MAD were concerned that clues are not being handled well. It is their perception that clues are going to Plans rather than Ops and action on them is being unduly delayed. It is felt that dog debriefs need improvement in the areas of discussion of POD, wind direction and follow-up.

The pros and cons of using dog handlers as IS in order to produce better dog tasks and better dog debriefs were discussed.

### PROCESS FOR REDUCING TRAINING LEVELS:

The process for reducing the training level of someone found to be incompetent was discussed. Dave Carter has included a section on due process in his proposal for changing the ops manual. However, that process refers to disciplinary actions, whereas this is not necessarily disciplinary. Keith Conover volunteered to write a due process specifically for reducing training levels in such situations. Recertification procedures, which will occur for a large portion of IS and IC members this January, should also help to take care of such problems.

### ALTERNATES OR PROXIES FOR ASRC BOD DELEGATES:

According to Bob Koester, the SCC requires that alternates or proxies for BOD Delegates would

have to be specifically allowed by our bylaws in order to be permissible.

Since ASRC bylaws do not do this, the only option available for replacing a Delegate who can not attend a particular meeting is:

1. The Delegate takes a Leave of Absence for a period encompassing the meeting date, and

2. The Group elects a replacement for that time period.

Although this practice is not specifically allowed either, the consensus of the Board is that it is acceptable.

## DIFFICULTY IN FINDING REPLACEMENT IC'S:

ş

Dave Carter raised the concern that several times in recent memory, we have suspended missions when more searching could have been done, except for the lack of an IC. Two solutions were suggested for the problem. First, we could simply hand responsibility for the search over to another agency and only withdraw ASRC resources, rather than suspend the entire mission. Second, we could revise the Ops Manual so that an IC is no longer required for the position of ASRC Agency Representative.

## 10 October 1992 Treasurer's Report

Our income since the last report was \$65.00. This was a donation given to us during the Pittsylvania Search for Gary Hall. AMRG also paid their 1992 dues. Our outcome includes monthly pager bills, minutes from last meeting being copied and mailed, and a \$167.20 file cabinet. The four drawer cabinet is in the ASRC locker and over two and a half drawers have already been filed with old mission files, not to mention the old political records.

The status on the tax-exempt has not changed due to the fact that the records have not gone from Gary Mectel to me. This is partial my fault for not actively pursuing them as vigorously as I should.

Any group that knows that it has not paid its 1992 dues should pay them to me immediately. All groups need to send me their 1993 dues, preferably by January 1, 1993.

A budget will be submitted for approval at the December Board meeting. Anyone with ideas about what needs to be included in the budget, please write, call, or see me.

One other thing to note, the copying of the minutes is an expensive proposition. The past two sets of minutes have cost \$78.34 and \$77.98 respectively for copying and \$19.70 and \$22.99 for postage. If this trend continues, we will spend \$600 just on BOD minutes and only take in at most \$350 in dues. This does not include other expenses such as paging, general membership meeting announcements, other mailings, or incidental costs such as file cabinets or SAR libraries.

This newsletter is to inform all ASRC affiliated groups and most especially the "medical-types" that as of the 30 Aug 92, BOD meeting, I have taken over the task of chairing the ASRC Medical Committee. The post was vacated when Dave Stooksbury moved to Atlanta on 16 Aug.

I am certain that many of you don't know anything about me; therefore, as a matter of introduction, I will briefly go over some of my credentials, so that you can have a better feel as to who I am and what I can do (hopefully) for the ASRC in the months to come:

I am a Navy Hospital Corpsman with over 21 years of clinical, emergency and field experience. I am currently an EMT-B working to finish NREMT Intermediate level testing and have recently completed the SOLO WEMT Program, the USAF Pararescue Advanced Casualty Care Course, and a Naval Special Warfare Critical Incident Stress Debriefing Course taught by Jeff Mitchell. I have also completed the Navy Cold Weather Medicine Course and served three years as a Navy Survival Instructor in Maine prior to moving to Virginia two years ago. I have over six years of search and rescue experience working in Alaska's Aleutian Islands, Maine and Virginia, and I am certified as a FUNSAR Instructor by NASAR. I am presently serving as the Medical Officer for Tidewater Search and Rescue Group and serve as a delegate to the Virginia SAR Council. I am also working with the WEMT Curriculum Development Project whenever I find some free time.

I hope that you can glean from my background that I believe in training. I also hope that it's apparent that I believe in search and rescue. Both of these ideals involve dedication and committment (spelled - W O R K !), and I intend to work as much as I possibly can to make a lot of the dreams within our community become a reality. I cannot do this alone. It is going to take a serious team effort from most of the ASRC medical personnel. This doesn't mean hours of slaving over a hot typewriter - I can do a lot of that stuff, but what I need is input and guidance on the issues that affect each of us. I also need a "committee". At this time, there is no official medical committee with the exception of one unofficial advisor. Therefore, I am asking for volunteers or appointees, one from each group, preferably a senior EMT, to be available periodically to brainstorm some ideas and possibly do a little "real work" towards getting realistic medical training and wilderness medical certifications/protocols established within our community.

Our first priority is to get all of our records straightened out. I recently received a roster from VA EMS and it is very outdated, and I'm suspicious that the same is true of the information contained in the ASRC Roster and possibly in our training files at the "Locker" in Charlottesville. As a reminder to the unenlightened, our EMS Agency license is up for renewal this December, and all of our records will be under review. Therefore, it is imperative that all personnel ensure training records are up to date. I will be making a working trip to Charlottesville sometime in mid-November to inspect and work on the records and update our rosters. Please get updated information (i.e., copies of cards/certificates) to me prior to 15 NOV, so that we can get this administrative evolution behind us, and move on to bigger and better things.

Another area we need to address in the future is attainment of local medical directors (LMD). If we ever hope to see the Wilderness EMT program get off the ground, and have the full impact and advanced capabilities that the program is designed to have, each group is going to need their own local medical director who is willing to train and "credential" EMT's in the necessary advanced skills that may be required in a backcountry setting. We will also need to be expanding our wilderness protocols in the future to include some of these more advanced skills. If each group is regularly working and training with their LMD who is reporting to the ASRC Operational Medical Directors (OMD), then it is easier for the OMD to grant authorization for performance of advanced skills in the "boonies".

That's about all I have for the moment. I'll try to get some kind of newsletter out after each BOD to keep all medical personnel up to date on the "latest and greatest". Remember, I need some inputs and committee members, so we can get hot on some of these pressing issues.

### TRAINING REPORT TO THE APPALACHIAN SEARCH & RESCUE CONFERENCE

### -September 23, 1992

On September 23, a note was sent to ASRC Training Officers with the following information.

FTL Test: The FTL written is ready for use by ASRC Group Training Officers. The following presents basic information and guidelines. Through October 5, no ASRC teams have requested the FTL test.

The written test is 100 questions. There are 7 sections with established questions in each section. Each question is worth one point. To pass the test, individuals must have at least 70% correct IN EACH SECTION of the test. Sections of the test may be retaken at the discretion of the ASRC Group Training Officer, but only after requesting a new copy of the test. The following guidelines have been established:

- When requested by the GTO, a copy of the FTL test and the answer key for that test will be mailed to the GTO. Each test page will be individually numbered, encrypted and dated.
- The test is not to be photocopied or reproduced in any manner. This test is copyrighted by the ASRC and is the property of the Appalachian Search & Rescue Conference, Inc.
- All completed written tests, when scored, are to be returned, along with the answer key to that test, to the ASRC Training Officer. Group training officers should enclose a note with each returned test indicating the results of the total FTL evaluation for each candidate.
- Persons successfully passing the written and field evaluation will be noted in designated ASRC rosters as Field Team Leaders.

Plans call for developing an additional 300 questions for the 7-section test so that different permutations of may be developed.

This written test is one part of the FTL evaluation process which is managed and administered by GTOs in each ASRC group. It is anticipated that GTOs will also conduct a field practicum exercise for FTL candidates. Note: One of the purposes of the annual ASRC training simulation, conducted for the last three years in November, has been to provide a field practicum opportunity for GTOs to test FTM and FTL candidates.

**November SAR Simulation:** A notice has been circulated regarding the November 20-22 SAR training simulation (see attached). We are hopeful that DES representatives will observe this training. The program is being designed as a full bore "to the wall" SAR exercise.

We are requesting the assistance of DES in locating a Virginia state park for the simulation so we do not have to contend with hunters on Saturday. Ideally, the state park will be located next to a state or national forest area to enable the search area to be extended on Saturday and into Sunday. Further information on this is expected shortly. ASRC Training Standards and Training Manual: All ASRC GTOs were asked on July 28 to send a list of reference materials used in your group FTM training program. It was emphasized that materials could be in any format, published or otherwise. We are attempting to gather basic information on what each ASRC group uses to conduct its training. One partial response has been received. I need to redouble my efforts on this.

## **BRMRG** Cellular Telephone Guidelines

These are a set of guidelines regarding the use of the BRMRG cellular telephone. The number for the telephone is (804) 981-2951.

Telephone use restrictions:

1. Due to the expense of cellular phone calls, only authorized members will be allowed to use the phone. Authorization may be predetermined at BRMRG business / BoD meetings. It may also be given during a search by the IC or an IS, or by the AO on call.

Telephone use instructions:

1. In the local Charlottesville / Albemarle area, the phone operates as a normal phone. To make a call, press the Power button, punch in the number you want to call and press the Send button. To end the call press the End/Clr button. If the phone is locked, key in the unlock code first: 951 (the last three digits of the cellular phone number). To receive a call the power must be on. If the phone rings, pick up the handset and the call will be answered. NOTE: Whenever the phone is used, calling out or receiving a call, a charge of 25 cents per minute is incurred.

2. Outside the local area the phone can be used if the ROAM indicator is on when the power is on. Making or receiving a call, in this instance, is more complicated. Please see attached instructions from Centel Cellular. NOTE: Roam charges are significantly higher than local charges. See attached instructions and costs.

3. Each call in or out will be recorded in a log included with the telephone.

Battery use instructions:

1. The battery option with this phone allows for its operation away from a power source. The battery is located in the compartment next to the phone. Under normal conditions the battery should provide 50 MINUTES of air time.

2. The battery can be charged from a car cigarette lighter or from an AC outlet. It is best to keep the battery fully charged at all times, or at least to avoid fully discharging it, since it may take up to 10 hours to recharge the battery. The battery is <u>not</u> subject to the "memory affect." The battery should be kept in a ventilated compartment.

3. The option of buying a second battery for this phone is being discussed. It will cost approximately \$52. Please direct comments on this option to the BRMRG communications officer.

### MARYLAND SEARCH & RESCUE GROUP (ESAR 616) REPORT TO THE APPALACHIAN SEARCH & RESCUE CONFERENCE

October 10, 1992

### New Member Recruitment

Significant recruiting is underway in the ESAR 616 program with approximately 15-20 new recruits. Additional recruits are expected. The first training weekend is scheduled for October 10-11 in the Shenandoah National Park near Front Royal.

### Communications Equipment and Related Issues

The team now has 7 ICOM H-16 radios plus one single frequency (155.160). The ICOM units may also be used for two base configurations with selective amplification from 50 to 100 watts.

ESAR 616, as an accredited MRA team, has received approval from the MRA to use its FCC license at 155.160 nationwide for emergency services. The ESAR-616 call sign is KBC-877 Maryland 616.

### Proposed MOU with Maryland State Police

On September 15, the Maryland State Police advised that the draft ASRC Memorandum of Understanding had been forwarded to their legal counsel for review. To date, no response has been received. On October 15, I will initiate a routine 30-day followup. While I am optimistic regarding their eventual approval, this entire process will continue to be fairly slow.

### Hurricane Andrew Response

A 11 person team from the Maryland Search & Rescue Group (ESAR 616), including several members from the Shenandoah Mountain Rescue Group (SMRG) and one member from the Allegheny Mountain Rescue Group (AMRG), assisted American Red Cross Disaster Services operations, by working with the National Disaster Medical Services (NDMS) program of the U.S. Public Health Service during a trip September 3-8 to south Dade County, Florida. ESAR-616 provides emergency services with the Maryland unit of the American Red Cross.

Services were provided throughout the South Dade County area assisting both the NDMS Environmental Health Task Force and other groups. Tasks included working with a Sheriffs unit blood hound unit from Charleston, South Carolina in searching a totally destroyed 300 unit trailer park at an Everglades Migrant Worker Camp before removal of debris by Navy Seabeas. Teams visited makeshift neighborhood first aid stations and medical service programs established by nurses, doctors and community hospitals

in damaged houses, schools and churches throughout. South Dade County to take back information to the NDMS Task Force on staffing and medical supply needs at each station. Team members also provided temporary repairs or arranged for repairs, and provided information on nearby services or more advanced services for referral of patients. Three team members also provided assistance in the NDMS incident command and communications Individual assignments included providing interpreter center. services one day for a small unit of 82nd Airborne medics going door to door offering first aid for residents in a large apartment complex which had been heavily damaged. Another assignment, with three Team medics, was accompanying a USPHS physician and a Florida Natural Resources Ranger into the Everglades in a large 4-wheel drive truck to look for migrant workers who might be injured, or in need of food and housing assistance.

### Mountain Rescue Capabilities in Virginia

ESAR-616 will be writing Ralph Wilfong at Virginia DES in the near future to describe the unit's capabilities in providing routine vertical and other mountain environment search and rescue services in Virginia. The MRA team within ESAR-616 is composed of adults and ESARs with a capability to provide relatively quick response to emergency situations. Technical equipment is maintained in the teams vehicle at all times.

## **REPORT TO THE ASRC**

Standards: An important meeting of the PSARC was held on Saturday, September 19, in Harrisburg to address important cross-cutting issues both in the Pennsylvania SAR Council and the general lost person search and rescue community in the Commonwealth. The following reviews the results of this meeting:

- 1. Standards for both professional volunteers providing lost person search and rescue services, and for groups and teams they are associated with are just beyond the horizon. The PSARC can wait for governmental agencies or other private groups to establish standards, or the PSARC can establish standards. The opinion of PSARC members present was that the PSARC should work through a process to take the lead in establishing standards.
- 2. While the development of group or team standard operating procedures is critical to the process of establishing creditable standards, at this time the development of individual standards should take precedence. Accordingly, a series of procedural steps were identified with time lines.
- 2.1 By the December 12, 1992, PSARC meeting, the Standards Committee will define, by skill and competency level descriptions, the following position descriptions. Note: Position description categories encompass a variety of terms and designations used to describe a series of position responsibilities.
  - $\checkmark$  trainee boot grunt call out qualified (coq)
  - ✓ field team member active member SAR tech I
  - $\checkmark$  SAR tech II field team leader
  - $\checkmark$  base operations personnel incident staff base tech I staff officers
  - $\checkmark$  incident commander team leader
  - $\checkmark$  rescue specialist
  - $\checkmark$  medic medical specialist
  - √ tracker
  - $\checkmark$  canine specialist search dog handler
- 2.2 The definitions developed in 2.1 above will be used to form, by April 1993, guidelines in the form of a users manual of recommended single title positions and descriptive responsibilities for each job title designation.

The Standards Committee will work to select position category titles and define position descriptions which are used in Pennsylvania, and which may be reciprocal in neighboring states. These guidelines will constitute the basis for position description standards to be later approved and adopted by the PSARC.

- 2.3 By April 1993, the Standards Committee will develop draft team/group operations standards for PSARC members.
- Note: Members of the Standards Committee will be meeting several times before the December 12 meeting in Harrisburg. Individuals and teams with comments and additional information are encouraged to write to PSARC Standards Committee Chairman Jim Howley at: Thornhurst Volunteer Fire & Rescue, Star Route, Box 119, Thornhurst PA 18424

**Operations:** Work continues to develop within PSARC an operational capability similar to that of the Colorado Search Rescue Board. Individuals have been tentatively identified as potential state mission coordinators. Further action is pending changes in the enabling legislation for the Pennsylvania Emergency Management Agency (PEMA).

FCC Radio License: Work is progressing on acquiring 3 tactical frequencies for use by PSARC teams. The FCC application has been coordinated and forwarded to the FCC/Gettysburg for action.

**Incorporation:** After a slow start, work will be getting underway to incorporate the PSARC as a non-profit corporation.

**Relations with Pennsylvania Emergency Management Agency:** Strides continue to be made in improving an already good working relationship with PEMA. Development of an MOU with PEMA is awaiting changes to enabling legislation for PEMA to authorize them to develop formal working relationships with search and rescue programs. The PSARC continues to collect and forward to PEMA resource information on wilderness SAR teams so this information may be incorporated into the PEMA emergency information system (EIS).

## **CAMILLE'S PROPOSAL FOR ALERT OFFICERS**

Alert Officers should be voted in by the ASRC BOD. This is because the Alert Officer (AO) gives the first impression of the conference. The AO makes a number of decision<sup>5</sup> about how the conference should respond to a search. The AO is responsible for giving the conference dispatch all neccessary information about a search, and at times the AO is the first contact with the Responsible Agent. The decisions the AO has to make, assumes a certain background knowledge of the conference, politics, and outside resources. For these reasons Alert Officers should be choosen carefully and to aid in choosing certain standards should be enforced.

This is my proposal:

An AO must be Incedent Staff with 20 hours of Group Dispatch experiance or a Field Team Lander with 30 hours of Conference Dispatch experiance.

An AO candidate must be recommended by his/her Group Dispatch Coordinator.

An<sup>all</sup> AOs must be voted in by the ASRC BOD.

### REMINDERS

<u>IS/IC RECERTIFICATION</u>: Recertification is required by the training standards on **01 JAN 92** for all IS and IC members who were initially certified before 01 JAN 90, which is the vast majority of us.

The standards also require serving at least four shifts in the past two years, divided among certain specified positions. I remind you, and please remind others: "It is the responsibility of the INDIVIDUAL to provide this documentation to the Board." I as secretary may be able to assist you in pulling specified material from specified mission files, if they exist. But you MUST at least tell me which files to look in, preferably which shift, and in what position you think you served.

I have copied the applicable sections of the training standards onto the back side of this sheet of paper.

Group rosters disagree with each other and with the Conference roster on who is or is not IS or IC. I have constructed the attached composite list of all those who are somewhere claimed as such. Please verify the accuracy of all information on this list. Please let Peter McCabe or myself know who needs to recertify, and the dates of certification of those who do not.

INDIVIDUAL ASRC DUES: Each group is required to collect \$1 from each member it wishes to claim on its roster and send the money to the ASRC Treasurer (Patrick Turner, at the same address as me) by 01 Jan 92.

One of these shifts must be as IC. It is the responsibility of the individual IC to provide this documentation to the Board.
- 3. Maintain ASRC FTL certification.
- 4. Receive a favorable vote of the ASRC Board of Directors.
- 5. (This recertification process does not preclude an IC being brought before the ASRC Board of Directors for review as needed, at any time.)
- 6. (The review cycle period shall begin the first of January of the year following the IC's initial certification.)

Appalachian Search and Rescue Conference-Center for Emergency Medicine of Western Pennsylvania Wilderness Emergency Medicine Curriculum Development Project Internal Report (ASRC/CEM Distribution Only) October 10, 1992 Courses The ASRC-CEM Curriculum is being used for a course sponsored by the Center for Emergency Medicine of Western Pennsylvania in western Pennsylvania the first and third weekends of November. We've had expressions of interest in using our curriculum for WEMT courses by the Coast Guard Training Center at Cape May, N.J., by Hahnemann University in Philadelphia, and by the EMS system in northeastern Utah. Our Curriculum is also being used as a basis for WEMT courses by the Canadian Institute of Safety, Search, and Rescue (Cochrane, Alberta), and St. John Ambulance, Manitoba HQ (Winnipeg). Textbook: Emergency Care in the Wilds: A Textbook for the Wilderness EMT, Wilderness Paramedic,, and Wilderness Command Physician We have submitted a Prospectus to Mosby, who is studying it. Saunders has also indicated interest in publishing it. Lesson Plan/Textbook Chapter Completion Introduction to WEMS, the WEMT, and the ASRC--CEM Curriculum: This section is "on hold." It still needs revision, and Scott Shuffield of TSAR has agreed to help with this. The Wilderness Environment: Hazards, Safety, and Patient Care Implications: Lesson Plan and Textbook Chapter complete and available. Patient Assessment: nearly complete. Scene Management, Communications, Reporting, and Documentation: Bogged down. Waiting (and waiting, and waiting) for Gene Harrison to take his voluminous handwritten notes and type them up. Wilderness Surgical Problems: Dr. Bender has completed a complete revision of the orthopedic sections. Dr. Conover has another 20-40 hours of editing to do on it. Then, we will release a new version. Dr. Honingford never did anything with the non-orthopedic section, so she is being replaced by Dr. Charles Stewart of Colorado Springs, CO. Thermal Regulation Heat-Related Disorders: These sections have been fairly complete for the past year, but Dr. Allan Doctor was never able to complete any more work on them. One of the new interns at the Center for Emergency Medicine of Western Pennsylvania is interested in finishing these sections and will be starting the final fine-tuning in the near future. Burns and Lightning: Lesson Plan and Textbook Chapter complete and available. Cold-Related Disorders: completed and apporoved by Editorial Board. Dr. Conover will be preparing a Lesson Plan and Textbook Chapter over the next month. Altitude Illness: Lesson Plan and Textbook Chapter complete and available. Bites and Stings: completed and apporoved by Editorial Board. Dr. Conover will be preparing a Lesson Plan and Textbook Chapter over the next month.

Wilderness Medical Problems: Completed. Dr. Shen is making a few last-minute changes to the Lesson Plan and Textbook, and they should be available next week. Wilderness Trauma: Next week, Mr. Yee and Dr. Conover will be finishing up some revisions and submitting a new version to the Task Group for review. It will need one or two more cycles of revision before completion. Pharmacology: Completed. Dr. Roth is completing some last-minute revisions in the Lesson Plan and Textbook Chapter; they should be released in the next week or two. **Disasters:** This section is stalled in the water, but Mr. Roche says he is now once again able to work on the section, and we have several new Task Group members. Orientation to/Review of Advanced Medical Skills: This section has been taught by Mr. Yee and Mr. Crist on a regular basis, and the content is well-agreed on. However, as far as written material, this section exists only as a set of Educational Objectives that is being circulated within the Task Group. Principles of General Medicine: This section is near-complete. It is waiting for Drs. Alson and Conover to make some changes in the psychology section. Stress Management and Critical Incident Stress Debriefing: Lesson Plan and Textbook Chapter complete and available.

Emergency Veterinary Medicine for Dogs and Horses: We're really just getting started on this section.

#### **OFFICER REPORTS**:

#### CHAIR:

The Chair reviewed the rules of the meeting. He also introduced his proposal for an updated Operations Manual, which includes proposals for annexes which describe various procedures. A copy was given to each Group.

Gary Mechtel expressed resentment of the manner in which he was relieved of Operations (without prior notice). He requested explanation of comments made at the time and inquired as to the availability of a tape. He also expressed concern that his proposals never received full consideration. The Chair apologized and a consensus was reached that Gary's proposals should be incorporated into the proposed update of the Operations Manual that is being considered by the BOD. Furthermore, Gary will present his ideas at the next BOD meeting.

The Chair also shared some ideas concerning the disaster SAR role of the Conference. He envisioned ASRC personnel staging at an army base and being brought in by helicopter for ground operations in problem areas identified by a previous CAP air sweep. Mark Pennington expressed concern that until the ASRC is included in the VA disaster plan, it would be difficult to interface with other agencies in a disaster situation. Keith Conover remarked that training for disasters should be kept to a minimum, and several other BOD members voiced agreement.

#### SECRETARY:

The Secretary apologized for the tardiness of the August minutes. He passed out a corrected version of the first page, which was incorrectly dated as April. A motion to accept the minutes as amended by the Secretary passed.

The filing cabinet was purchased. Search documentation is apparently becoming more voluminous, as the third drawer of four is already half-full with 1992 alone.

Several letters requesting information on training materials/courses were received and forwarded to appropriate personnel.

It was suggested to the Communications Secretary that an updated commo crib sheet be created and that information on each Group's radios (charging, channels, use) be collected and distributed Conference-wide.

Keith Conover gave a report on the status of the W-EMT Curriculum Development Project. A written report is attached.

Gary Mechtel requested that a policy be created concerning medical activities at fundraisers, especially across state lines. He also suggested a MOU on interstate medical activities with all our primary states of operation.

The Virginia OMD approved Bob Koester's <u>Outdoor First Aid</u> as medical protocols for the ASRC with three changes. The book is written for the lay public. Inserts will be provided to ASRC members or Groups purchasing the book which cover the required changes.

Keith Conover (OMD for PA) stated that separate protocols for PA will be developed in 1993.

The Surry County search produced at least one case of confirmed Rocky Mt. Spotted Fever and at least one case of confirmed Lyme Disease.

Keith Conover shed more light on the OSHA requirements issue. VA is a "planned" state. The surrounding states are not. In "unplanned states" it has been recommended that the OSHA requirements be treated as though they apply to volunteers until notified otherwise.

TAX-EXEMPT STATUS:

Bob Koester received final financial statements from the Treasurer today.

FTM TEST: Hopefully will be ready by end of year.

OPERATIONS MANUAL: See ASRC Chair report.

TRAINING MANUAL:

Scott Shuffield feels that most material commercially available is outdated, and buying a large library is not advisable. He will continue with evaluation of a few manuals including the old ASRC manual, the SARTA manual and Cooper's <u>Fundamentals of SAR</u>. Keith Conover stated that he may be able to work on a manual starting in July.

RSAR 36-MONTH REVIEW: Tabled until Dec. meeting.

#### ANNUAL MEETING REQUIREMENTS OF SCC:

Bob Koester reported that the requirements have been met.

#### **BYLAW CHANGE:**

The letters sent out by Dave Carter concerning the bylaw change failed to produce a sufficient response without relying on the idea of counting a lack of response as a positive vote. Bob Koester questioned the legality of that method of counting votes, as it produced no written record of sufficient votes to pass the motion. He also suggested that the change to the bylaws could be better worded.

It was decided to try again, using a different method to encourage voting. Bob Koester and Keith Conover drafted new wording for the amendment, AS FOLLOWS:

Resolved, that the Board send a mail ballot, with a cover letter describing the need for a re-vote, including an ASRC-addressed, stamped post card, to all Active Members, with the following motion:

Resolved, that the Article V (Amendments) of the ASRC Bylaws be revised as follows:

Delete current Section 2. Replace with a new Section 2: "The proposed amendment shall be adopted upon receiving more than two-thirds of the votes entitled to be cast by members present or represented by proxy at the meeting."

Add a new Section 3: "Written notice stating the place, day, and hour of the meeting where Bylaw amendments shall be considered shall be delivered, either personally or by mail, to each Active Member, not less than twenty-five nor more than fifty days before the date of the meeting. The specific proposed amendments need not be included in this notice."

The Secretary will be responsible for assembling and mailing the ballots and letters, as soon as the Chair provides him with mailing labels and the letter, and Keith Conover provides him with the postcard ballots.

#### **NEW BUSINESS:**

#### **PROMOTIONS:**

Jenny Burmester, SMRG GTO, made a motion that Paul DeHaven be promoted to Incident Staff, having met all the requirements. The motion passed.

Bob Koester, acting for the BRMRG GTO, proposed that Camille Birmingham, Patrick Turner and Greg Perron be promoted to Incident Staff. It was determined that they met all the requirements. A motion to vote on all three candidates together passed, and a motion to promote all three candidates as proposed passed.

Bob Koester also proposed that Bruce Hemmer be promoted to Incident Commander. It was determined that he met all the requirements, the required letters of support were read, and a motion to promote the candidate as proposed passed.

#### ASRC BUSINESS CARDS:

A motion passed to buy 1000 ASRC business cards (without names of individuals printed on them) to be distributed to the Groups. These would be primarily intended for inclusion in ops kits. The Treasurer will establish a printer, who will be authorized to print further cards for individuals on the ASRC roster, at the individual's expense, with the individual's name printed on the cards. The only titles permitted will be medical certifications (EMT and above) and educational degrees (such as PhD). The cards will use the DES EOC phone number for an emergency contact number.

#### ASRC INK-PENS:

A long time ago, the BOD expressed interest in purchasing pens with an ASRC logo on them for PR purposes. An auxiliary benefit would be that pens with an alternate color scheme could also be printed which would be assigned to ops kits only, as a way of cutting down on attrition of ops kit pens. David Carter will investigate the cost involved and report at the next BOD meeting.

#### MINUTES:

To reduce the cost of producing and mailing the minutes, it was decided that including material other than routine reports in the distributed minutes will be required only if the Secretary is specifically requested to do so. Whether appointed officers (as opposed to elected officers) should be referred to as "Officers," "Committee Chairs" or some other title will be evaluated by the ASRC Chair.

#### STORAGE:

The Treasurer will investigate the cost of a storage facility for ASRC archives.

#### **CONFERENCE SAFETY OFFICER:**

A motion passed as follows:

Resolved, that the ASRC Chairman appoint, on a continuing basis, a Conference Safety Officer. The duties of the Conference Safety Officer shall be:

1. to investigate all accidents, injuries, illness, and "near-misses" that occur on ASRC or Group training sessions, simulations, or missions, and

2. to make recommendations to the ASRC Board regarding such incidents.

The Chair appointed Gary Mechtel to the position, and he accepted the appointment. Ensuing discussion suggested that demonstrating such concern and prudence may make it easier to get insurance coverage if we ever decide to do so. The possibility of also having Group Safety Officers was discussed.

#### ALERT/DISPATCH:

Camille Birmingham, the BRMRG Alert/Dispatch Coordinator, made a proposal concerning what the qualifications for ASRC AO's should be. A copy is attached. The proposal was tabled to the December meeting, when Gary Mechtel will make a presentation of his proposals concerning the alert/dispatch structure.

Camille also presented the attached form for collecting information on each IS, IC and Tracker in the Conference for Conference Dispatch purposes.

Dave Carter asked Camille to provide each Group with current information on how dispatch works. She will give a presentation at the next meeting.

Reports of any problems with Dispatch should go to Camille. There was a problem with the pager net in the DC area on a recent search - it was Metrocall's fault. It is important to respond to pager tests so that these problems can be detected!

#### 1-800-800-ASRC:

The Treasurer will again investigate the feasibility of the ASRC taking over financial responsibility for the above toll-free #, so that it can be used by all ASRC members during missions. USE IS CURRENTLY RESTRICTED to BRMRG members and staff at Base. The issue has been raised again because EOC no longer wants individuals enroute to a mission using the EOC toll-free number to make sure the search is still in progress.

## ASTM PROPOSED STANDARD SAR TERMINOLOGY:

William Dixon, the ASRC Representative to ASTM, presented the attached list of standard SAR terminology that ASTM has proposed. He asked for input by 20 Oct 92.

William wishes to **RESIGN as ASTM Representative**. Anyone wishing to replace him should speak to him or the ASRC Chair as soon as possible.

#### DOG HANDLERS' CONCERNS:

William Dixon mentioned that members of MAD were concerned that clues are not being handled well. It is their perception that clues are going to Plans rather than Ops and action on them is being unduly delayed. It is felt that dog debriefs need improvement in the areas of discussion of POD, wind direction and follow-up.

The pros and cons of using dog handlers as IS in order to produce better dog tasks and better dog debriefs were discussed.

#### PROCESS FOR REDUCING TRAINING LEVELS:

The process for reducing the training level of someone found to be incompetent was discussed. Dave Carter has included a section on due process in his proposal for changing the ops manual. However, that process refers to disciplinary actions, whereas this is not necessarily disciplinary. Keith Conover volunteered to write a due process specifically for reducing training levels in such situations. Recertification procedures, which will occur for a large portion of IS and IC members this January, should also help to take care of such problems.

#### ALTERNATES OR PROXIES FOR ASRC BOD DELEGATES:

According to Bob Koester, the SCC requires that alternates or proxies for BOD Delegates would

have to be specifically allowed by our bylaws in order to be permissible.

Since ASRC bylaws do not do this, the only option available for replacing a Delegate who can not attend a particular meeting is:

1. The Delegate takes a Leave of Absence for a period encompassing the meeting date, and

2. The Group elects a replacement for that time period.

Although this practice is not specifically allowed either, the consensus of the Board is that it is acceptable.

## DIFFICULTY IN FINDING REPLACEMENT IC'S:

Dave Carter raised the concern that several times in recent memory, we have suspended missions when more searching could have been done, except for the lack of an IC. Two solutions were suggested for the problem. First, we could simply hand responsibility for the search over to another agency and only withdraw ASRC resources, rather than suspend the entire mission. Second, we could revise the Ops Manual so that an IC is no longer required for the position of ASRC Agency Representative.

Our income since the last report was \$65.00. This was a donation given to us during the Pittsylvania Search for Gary Hall. AMRG also paid their 1992 dues. Our outcome includes monthly pager bills, minutes from last meeting being copied and mailed, and a \$167.20 file cabinet. The four drawer cabinet is in the ASRC locker and over two and a half drawers have already been filed with old mission files, not to mention the old political records.

The status on the tax-exempt has not changed due to the fact that the records have not gone from Gary Mectel to me. This is partial my fault for not actively pursuing them as vigorously as I should.

Any group that knows that it has not paid its 1992 dues should pay them to me immediately. All groups need to send me their 1993 dues, preferably by January 1, 1993.

A budget will be submitted for approval at the December Board meeting. Anyone with ideas about what needs to be included in the budget, please write, call, or see me.

One other thing to note, the copying of the minutes is an expensive proposition. The past two sets of minutes have cost \$78.34 and \$77.98 respectively for copying and \$19.70 and \$22.99 for postage. If this trend continues, we will spend \$600 just on BOD minutes and only take in at most \$350 in dues. This does not include other expenses such as paging, general membership meeting announcements, other mailings, or incidental costs such as file cabinets or SAR libraries.

# MEDICAL NEWSLETTER

## 07 OCTOBER 1992

This newsletter is to inform all ASRC affiliated groups and most especially the "medical-types" that as of the 30 Aug 92, BOD meeting, I have taken over the task of chairing the ASRC Medical Committee. The post was vacated when Dave Stooksbury moved to Atlanta on 16 Aug.

I am certain that many of you don't know anything about me; therefore, as a matter of introduction, I will briefly go over some of my credentials, so that you can have a better feel as to who I am and what I can do (hopefully) for the ASRC in the months to come:

I am a Navy Hospital Corpsman with over 21 years of clinical, emergency and field experience. I am currently an EMT-B working to finish NREMT Intermediate level testing and have recently completed the SOLO WEMT Program, the USAF Pararescue Advanced Casualty Care Course, and a Naval Special Warfare Critical Incident Stress Debriefing Course taught by Jeff Mitchell. I have also completed the Navy Cold Weather Medicine Course and served three years as a Navy Survival Instructor in Maine prior to moving to Virginia two years ago. I have over six years of search and rescue experience working in Alaska's Aleutian Islands, Maine and Virginia, and I am certified as a FUNSAR Instructor by NASAR. I am presently serving as the Medical Officer for Tidewater Search and Rescue Group and serve as a delegate to the Virginia SAR Council. I am also working with the WEMT Curriculum Development Project whenever I find some free time.

I hope that you can glean from my background that I believe in training. I also hope that it's apparent that I believe in search and rescue. Both of these ideals involve dedication and committment (spelled - W O R K !), and I intend to work as much as I possibly can to make a lot of the dreams within our community become a reality. I cannot do this alone. It is going to take a serious team effort from most of the ASRC medical personnel. This doesn't mean hours of slaving over a hot typewriter - I can do a lot of that stuff, but what I need is input and guidance on the issues that affect each of us. I also need a "committee". At this time, there is no official medical committee with the exception of one unofficial advisor. Therefore, I am asking for volunteers or appointees, one from each group, preferably a senior EMT, to be available periodically to brainstorm some ideas and possibly do a little "real work" towards getting realistic medical training and wilderness medical certifications/protocols established within our community.

Our first priority is to get all of our records straightened out. I recently received a roster from VA EMS and it is very outdated, and I'm suspicious that the same is true of the information contained in the ASRC Roster and possibly in our training files at the "Locker" in Charlottesville. As a reminder to the unenlightened, our EMS Agency license is up for renewal this December, and all of our records will be under review. Therefore, it is imperative that all personnel ensure training records are up to date. I will be making a working trip to Charlottesville sometime in mid-November to inspect and work on the records and update our rosters. Please get updated information (i.e., copies of cards/certificates) to me prior to 15 NOV, so that we can get this administrative evolution behind us, and move on to bigger and better things.

Another area we need to address in the future is attainment of local medical directors (LMD). If we ever hope to see the Wilderness EMT program get off the ground, and have the full impact and advanced capabilities that the program is designed to have, each group is going to need their own local medical director who is willing to train and "credential" EMT's in the necessary advanced skills that may be required in a backcountry setting. We will also need to be expanding our wilderness protocols in the future to include some of these more advanced skills. If each group is regularly working and training with their LMD who is reporting to the ASRC Operational Medical Directors (OMD), then it is easier for the OMD to grant authorization for performance of advanced skills in the "boonies".

That's about all I have for the moment. I'll try to get some kind of newsletter out after each BOD to keep all medical personnel up to date on the "latest and greatest". Remember, I need some inputs and committee members, so we can get hot on some of these pressing issues.

# TRAINING REPORT TO THE APPALACHIAN SEARCH & RESCUE CONFERENCE

On September 23, a note was sent to ASRC Training Officers with the following information.

FTL Test: The FTL written is ready for use by ASRC Group Training Officers. The following presents basic information and guidelines. Through October 5, no ASRC teams have requested the FTL test.

The written test is 100 questions. There are 7 sections with established questions in each section. Each question is worth one point. To pass the test, individuals must have at least 70% correct IN EACH SECTION of the test. Sections of the test may be retaken at the discretion of the ASRC Group Training Officer, but only after requesting a new copy of the test. The following guidelines have been established:

- When requested by the GTO, a copy of the FTL test and the answer key for that test will be mailed to the GTO. Each test page will be individually numbered, encrypted and dated.
- The test is not to be photocopied or reproduced in any manner. This test is copyrighted by the ASRC and is the property of the Appalachian Search & Rescue Conference, Inc.
- All completed written tests, when scored, are to be returned, along with the answer key to that test, to the ASRC Training Officer. Group training officers should enclose a note with each returned test indicating the results of the total FTL evaluation for each candidate.
- Persons successfully passing the written and field evaluation will be noted in designated ASRC rosters as Field Team Leaders.

Plans call for developing an additional 300 questions for the 7-section test so that different permutations of may be developed.

This written test is one part of the FTL evaluation process which is managed and administered by GTOs in each ASRC group. It is anticipated that GTOs will also conduct a field practicum exercise for FTL candidates. Note: One of the purposes of the annual ASRC training simulation, conducted for the last three years in November, has been to provide a field practicum opportunity for GTOs to test FTM and FTL candidates.

**November SAR Simulation**: A notice has been circulated regarding the November 20-22 SAR training simulation (see attached). We are hopeful that DES representatives will observe this training. The program is being designed as a full bore "to the wall" SAR exercise.

We are requesting the assistance of DES in locating a Virginia state park for the simulation so we do not have to contend with hunters on Saturday. Ideally, the state park will be located next to a state or national forest area to enable the search area to be extended on Saturday and into Sunday. Further information on this is expected shortly. ASRC Training Standards and Training Manual: All ASRC GTOs were asked on July 28 to send a list of reference materials used in your group FTM training program. It was emphasized that materials could be in any format, published or otherwise. We are attempting to gather basic information on what each ASRC group uses to conduct its training. One partial response has been received. I need to redouble my efforts on this.

# COMBINED APPALACHIAN SEARCH & RESCUE CONFERENCE TRAINING SIMULATION

- WHAT TRAINING SIMULATION Lost person(s) search and rescue
- WHEN November 20-22, 1992 -- beginning during the afternoon of November 20, 1992 from 1515 hours for initial alerting and call-out.

WHERE Simulation will be in Virginia. Site to be determined.

ACTIVITIES This will be a full scale lost person search simulation. Activities will include an overhead response team to evaluate the request for assistance, full scale call-out, with day/night search operations planned over an extended area.

A SAR simulation team will provide guidance and information to the Incident Staff shifts running the operation. Present plans are for a "find and rescue activity" sometime Saturday night or Sunday morning.

This simulation will evaluate the present capability of ASRC groups to provide a coordinated response in rugged terrain when a request for assistance is received. This exercise will also provide a valuable opportunity for FTL candidates to lead field teams, and for IS and IC candidates to work shifts at mission base. Note: Incident Staff and Incident Commander candidates should identify their availability to their Group Training Officers so this information may be forwarded to training simulation managers.

EQUIPMENT 24-hour packs to include rations and water. Plan on bivouacking in the field at least one night, and being on different search team missions on a 24-hour clock. Count on weather being wet and cold, and nights probably will be into the 20s. Note: 48 hour packs will only be available at mission base which will probably be a primitive site. 48 hour packs to also include your additional food for the 2nd day, shelter, etc.

Bring full personal and team semi-tech and technical gear. Headlamps and safety glasses/goggles for night ops are required.

EMERGENCIES Telephone numbers for emergency communications for your SAR group will be announced at alerting and call-out.



# BRMRG Cellular Telephone Guidelines

These are a set of guidelines regarding the use of the BRMRG cellular telephone. The number for the telephone is (804) 981-2951.

Telephone use restrictions:

1. Due to the expense of cellular phone calls, only authorized members will be allowed to use the phone. Authorization may be predetermined at BRMRG business / BoD meetings. It may also be given during a search by the IC or an IS, or by the AO on call.

Telephone use instructions:

1. In the local Charlottesville / Albemarle area, the phone operates as a normal phone. To make a call, press the Power button, punch in the number you want to call and press the Send button. To end the call press the End/Clr button. If the phone is locked, key in the unlock code first: 951 (the last three digits of the cellular phone number). To receive a call the power must be on. If the phone rings, pick up the handset and the call will be answered. NOTE: Whenever the phone is used, calling out or receiving a call, a charge of 25 cents per minute is incurred.

2. Outside the local area the phone can be used if the **ROAM** indicator is on when the power is on. Making or receiving a call, in this instance, is more complicated. Please see attached instructions from Centel Cellular. **NOTE:** Roam charges are significantly higher than local charges. See attached instructions and costs.

3. Each call in or out will be recorded in a log included with the telephone.

Battery use instructions:

1. The battery option with this phone allows for its operation away from a power source. The battery is located in the compartment next to the phone. Under normal conditions the battery should provide 50 MINUTES of air time.

2. The battery can be charged from a car cigarette lighter or from an AC outlet. It is best to keep the battery fully charged at all times, or at least to avoid fully discharging it, since it may take up to 10 hours to recharge the battery. The battery is <u>not</u> subject to the "memory affect." The battery should be kept in a ventilated compartment.

3. The option of buying a second battery for this phone is being discussed. It will cost approximately \$52. Please direct comments on this option to the BRMRG communications officer.

# MARYLAND SEARCH & RESCUE GROUP (ESAR 616) REPORT TO THE APPALACHIAN SEARCH & RESCUE CONFERENCE

October 10, 1992

New Member Recruitment

Significant recruiting is underway in the ESAR 616 program with approximately 15-20 new recruits. Additional recruits are expected. The first training weekend is scheduled for October 10-11 in the Shenandoah National Park near Front Royal.

Communications Equipment and Related Issues

The team now has 7 ICOM H-16 radios plus one single frequency (155.160). The ICOM units may also be used for two base configurations with selective amplification from 50 to 100 watts.

ESAR 616, as an accredited MRA team, has received approval from the MRA to use its FCC license at 155.160 nationwide for emergency services. The ESAR-616 call sign is KBC-877 Maryland 616.

# Proposed MOU with Maryland State Police

On September 15, the Maryland State Police advised that the draft ASRC Memorandum of Understanding had been forwarded to their legal counsel for review. To date, no response has been received. On October 15, I will initiate a routine 30-day followup. While I am optimistic regarding their eventual approval, this entire process will continue to be fairly slow.

#### Hurricane Andrew Response

A 11 person team from the Maryland Search & Rescue Group (ESAR 616), including several members from the Shenandoah Mountain Rescue Group (SMRG) and one member from the Allegheny Mountain Rescue Group (AMRG), assisted American Red Cross Disaster Services operations, by working with the National Disaster Medical Services (NDMS) program of the U.S. Public Health Service during a trip September 3-8 to south Dade County, Florida. ESAR-616 provides emergency services with the Maryland unit of the American Red Cross.

Services were provided throughout the South Dade County area assisting both the NDMS Environmental Health Task Force and other groups. Tasks included working with a Sheriffs unit blood hound unit from Charleston, South Carolina in searching a totally destroyed 300 unit trailer park at an Everglades Migrant Worker Camp before removal of debris by Navy Seabeas. Teams visited makeshift neighborhood first aid stations and medical service programs established by nurses, doctors and community hospitals in damaged houses, schools and churches throughout South Dade County to take back information to the NDMS Task Force on staffing and medical supply needs at each station. Team members also provided temporary repairs or arranged for repairs, and provided information on nearby services or more advanced services for referral of patients. Three team members also provided assistance in the NDMS incident command and communications Individual assignments included providing interpreter center. services one day for a small unit of 82nd Airborne medics going door to door offering first aid for residents in a large apartment complex which had been heavily damaged. Another assignment, with three Team medics, was accompanying a USPHS physician and a Florida Natural Resources Ranger into the Everglades in a large 4-wheel drive truck to look for migrant workers who might be injured, or in need of food and housing assistance.

# Mountain Rescue Capabilities in Virginia

ESAR-616 will be writing Ralph Wilfong at Virginia DES in the near future to describe the unit's capabilities in providing routine vertical and other mountain environment search and rescue services in Virginia. The MRA team within ESAR-616 is composed of adults and ESARs with a capability to provide relatively quick response to emergency situations. Technical equipment is maintained in the teams vehicle at all times.

## **REPORT TO THE ASRC**

- **Standards:** An important meeting of the PSARC was held on Saturday, September 19, in Harrisburg to address important cross-cutting issues both in the Pennsylvania SAR Council and the general lost person search and rescue community in the Commonwealth. The following reviews the results of this meeting:
- 1. Standards for both professional volunteers providing lost person search and rescue services, and for groups and teams they are associated with are just beyond the horizon. The PSARC can wait for governmental agencies or other private groups to establish standards, or the PSARC can establish standards. The opinion of PSARC members present was that the PSARC should work through a process to take the lead in establishing standards.
- 2. While the development of group or team standard operating procedures is critical to the process of establishing creditable standards, at this time the development of individual standards should take precedence. Accordingly, a series of procedural steps were identified with time lines.
- 2.1 By the December 12, 1992, PSARC meeting, the Standards Committee will define, by skill and competency level descriptions, the following position descriptions. Note: Position description categories encompass a variety of terms and designations used to describe a series of position responsibilities.
  - $\sqrt{}$  trainee boot grunt call out qualified (coq)
  - $\checkmark$  field team member active member SAR tech I
  - $\checkmark$  SAR tech II field team leader
  - $\checkmark$  base operations personnel incident staff base tech I staff officers
  - $\checkmark$  incident commander team leader
  - $\checkmark$  rescue specialist
  - $\checkmark$  medic medical specialist
  - √ tracker
  - $\checkmark$  canine specialist search dog handler
- 2.2 The definitions developed in 2.1 above will be used to form, by April 1993, guidelines in the form of a users manual of recommended single title positions and descriptive responsibilities for each job title designation.

The Standards Committee will work to select position category titles and define position descriptions which are used in Pennsylvania, and which may be reciprocal in neighboring states. These guidelines will constitute the basis for position description standards to be later approved and adopted by the PSARC.

- 2.3 By April 1993, the Standards Committee will develop draft team/group operations standards for PSARC members.
- Note: Members of the Standards Committee will be meeting several times before the December 12 meeting in Harrisburg. Individuals and teams with comments and additional information are encouraged to write to PSARC Standards Committee Chairman Jim Howley at: Thornhurst Volunteer Fire & Rescue, Star Route, Box 119, Thornhurst PA 18424

**Operations:** Work continues to develop within PSARC an operational capability similar to that of the Colorado Search Rescue Board. Individuals have been tentatively identified as potential state mission coordinators. Further action is pending changes in the enabling legislation for the Pennsylvania Emergency Management Agency (PEMA).

FCC Radio License: Work is progressing on acquiring 3 tactical frequencies for use by PSARC teams. The FCC application has been coordinated and forwarded to the FCC/Gettysburg for action.

**Incorporation:** After a slow start, work will be getting underway to incorporate the PSARC as a non-profit corporation.

**Relations with Pennsylvania Emergency Management Agency:** Strides continue to be made in improving an already good working relationship with PEMA. Development of an MOU with PEMA is awaiting changes to enabling legislation for PEMA to authorize them to develop formal working relationships with search and rescue programs. The PSARC continues to collect and forward to PEMA resource information on wilderness SAR teams so this information may be incorporated into the PEMA emergency information system (EIS).

- 2. accessory cord, n any cordage (rope) of nominal diameter of 9mm or less. Usually manufactured of low stretch synthetic fiber yarns in a kernmantle type construction.

- 4. ascender, n mechanical camming device which grips the rope in one direction (hard ascender), or certain rope hitches (soft ascender)

## **CAMILLE'S PROPOSAL FOR ALERT OFFICERS**

Alert Officers should be voted in by the ASRC BOD. This is because the Alert Officer (AO) gives the first impression of the conference. The AO makes a number of decision<sup>4</sup> about how the conference should respond to a search. The AO is responsible for giving the conference dispatch all neccessary information about a search, and at times the AO is the first contact with the Responsible Agent. The decisions the AO has to make, assumes a certain background knowledge of the conference, politics, and outside resources. For these reasons Alert Officers should be choosen carefully and to aid in choosing certain standards should be enforced.

This is my proposal:

An AO must be Incedent Staff with 20 hours of Group Dispatch experiance or a Field Team Leader with 30 hours of Conference Dispatch experiance.

An AO candidate must be recommended by his/her Group Dispatch Coordinator.

An all AOs must be voted in by the ASRC BOD.

Well.. I suppose I should not expect much, but I had hoped for a comment (at least one) about this concept of a news letter. I didn't get one but I am going to press on anyway.

Three missions have caused me a great deal of heart burn. The Floyd mission, the Surry mission, and the Pittsylvania both had a common problem. LACK OF IC's.

When I look through the roster and start comparing who shows up on incidents as an IC and who is on the list, the comparison bring out that the real list of IC's a lot smaller than the "qualified" list. I am concerned that many of you are not qualified by our rules to maintain your IC status because you do not respond frequently enough. I have asked Peter McCabe, our TO, to ferret out a list of dates of acceptance by the BOD and we are going to hold everyone's feet to the fire. If you haven't met the requirements you will be reduced in training level appropriately.

Some of the folks on the list have voluntarily withdrawn and I can only praise them for being realistic about their life and current interests. Some of you haven't had the (some non threatening word) to resign as IC's or IS's even though it is transparent to those of us that are active, who can be counted on.

I received a great deal of flak from the SAR Council because I suspended the Floyd incident. I cannot begin to tell you how hard it was to do that. Ruth and I both felt that the subject was in the area, but we couldn't get an IC and the ASRC rules say there must be an IC. I felt then and now that we had no choice. I was furious that out of, then 13 IC's, I could not get one person to commit to coming and running the mission, I even had arranged air transport, for one person who said they might be able to. When it was arranged they backed out.

The Surry mission happens and I am faced with the same problem. ASRC committed itself to respond to this mission. The AO asked me to go as IC and check things out. I did and made the decision to involve us. Late on Sunday I was trying to get an IC and I am asked by a new dispatch person a series of question given to her by William Dixon as evaluation of the mission. While I was incensed that another IC would question my decision process without even having the (another non threatening word) to talk to me directly, I responded to the questions as a professional.

I was told that there was no IC available after repeated phone calls from dispatch. It looked like we were going to have to suspend after I had just had a planning meeting with the RA, County Administrator, Board of Supervisor Chairman, and my staff who all felt we should continue for another shift. Ruth and I went away from the area for a moment and started biting trees. It was absolutely ridiculous that we could not find an IC. It was

## Floyd all over again.

Fortunately Ralph Wilfong, a Commonwealth of Virginia IC, was willing to give up his holiday and take over the mission. By the end of the shift on Monday he decided to suspend, but felt as I did that the man is in the area. And, as events turned out, the subject was in the area. It was same, same for Floyd as well.

Folks, this has got to stop!!!!!!

I fully intend to have the BOD review the responses of those listed as IS and IC and if you are not meeting our rules, then recommend that you be lowered in training status. You cannot keep your skills up when you do not respond to incidents in letter and intent of the rules. I am very much aware of all the pitfalls of being employed, having family, et cetera. I have all of the same issues that you have and like you must pay the fiddler after I have chosen to dance SAR.

Look at what is required to maintain IC status. Some of you have not met the IS let alone IC standards. But, what about the FTL standards (which we are required to meet as well? I haven't met the FTL requirements either and I am now probably the most active IC. Why? Because when I can respond to missions I wind up being IC. Why? Because no one else will take the incident.

To top all of this off we are out soliciting more business in Maryland, Pennsylvania and western VA. How can we meet our current needs and also those of new areas we are exploring?

Now will requiring you to maintain the standards fix the problem of not enough IC's and IS's responding? No, but it will force you to consider if you want to do this and for those who decide to participate perhaps will increase their responses. It will not increase the number of IC's and IS's.

We may just need to change our rules? I think we do. As Dr. Conover said to me when discussing this. Perhaps the rules are to idealistic.

## RESOURCE ORDERS IN VIRGINIA Some thoughts

How do you make up a resource order for DES? You should know that you are supposed to do this.

DES does not want "Y,all come". They want a specific request for numbers of airscent dog teams, man trackers, FTL's, FTM's, etc. Then, armed with that order they will go through the various Groups with MOU's and try and produce what you have asked for.

In ASRC we are very lax in our control of resources. If I request 10 FTL's based on what I am going to talk about next, I get a full callout and whatever is available. This can and should be controlled by the Dispatchers, at Group and Conference level (Yes, Dawn it can be done if the system is structured properly) so that it doesn't happen that all the available FTL's show up when we only needed X number. But, the control of resources is another issue, for another time.

Just how do you build a resource order? Well, since there is no training on this with the possible exception of some words on it in the "IC for SAR" course, I have my own methods which I will share with you.

First I do and/or look at the Mattson consensus, the Cumulative shifting POA's, the clues, the work already done, gut feelings of experienced people and then examine what we want to do the next shift (I use 12 hours 0600/1800 - 1800/0600).

I base the numbers on 1/2 of the total number of planned and or desired tasks. When I segment, I segment in task size areas. Since I plan for tasks no larger than 144 acres (about a four hour task), It is possible for a team to do three tasks in four hour period, but realistically I can count on two per shift per team. It is my assumption that I can get people into the field in the first hour of the shift (based on the previous shift doing the planning, preparing the TAF's, etc.[or doing 'operational' planning, usually in the first and second incident shift.]). The people will complete a task, debrief, rest, refuel and do it again. Depending on the terrain, weather, hour of day, day of incident, they may be able to do a third, but I don't count on that happening.

If I am using a planning section I usually ask for the planned tasks and then estimate the numbers I need. If I am not using a Plans section I will estimate based on what I think we can reasonable do given urgency, responsiveness of the Conference and other SAR resources, weather, location of search, et cetera.

I will ask for sufficient Team Leader's to man the Dog tasks, the hasty sweeps, the mantrackers, etc that are planned (or anticipated). I ask for FTM's to man sweep tasks, hastys, etc. I will in the future ask for COQ's by number (a recent error on my part, was not asking for these folks by number) to man sweeps, etc. I ask for air scent dog teams, trailing/tracking dogs, other specialized resources as well.

Thus I can come up with a specific number of resources such as 10 FTL's, 20 FTM's, 10 COQ, 2 air scent dogs, 1 mantracker, 1 helicopter with FLIR. This I call to the SARDO and they get what they can. Remember CAP is a resource but you have to ask for specifically and build a resource order for them as well. Do you know what CAP is are capable of?

There is a problem with resource ordering that has nothing to do with the system. I ask for 2 air scent dogs but get 4 air scent dogs because someone in the dog group decides to send a trainee dog team because "they (the team) needs experience, and they (the base) won't mind". As Ralph Wilfong has pointed out, this has been OK if these people are used to support an already certified dog team, but the base still needs to assign a FTL with the Handler. This also happens with ASRC when we go to "full callout". This usually translates to "send everybody available". NOT!!!!!! For me as IC, this means send what I asked for. I am looking to the incident needs but also to the possibility of other incidents happening at the same time.

#### Notice something about my process?

First, I expect people to be able to pull a twelve hour shift. I do not want people who can stay for three hours/six hours. It is hardly worth their coming and the time it takes to get them up to speed for a task/job before they are gone.

Second, I am not using Logistics to do the ordering. "By the Book"

the Logistics Chief should be doing the ordering of resources, but we do not have sufficient trained IS's that can do Logistics well enough to suit me, so I do it myself. As an aside, I do not believe that Logistics can be done by any warm body. Most incidents do not grow large enough to warrant establishing a logistics section. My experience is that they need to be trained experienced IS staff, most especially for large scale incidents.

I would encourage all of the IC's and IS's who respond regularly to do place orders as mentioned and not just pull them out of the air. It does mean a reasoned, logical approach to the request. It means taking time to think things through.

### Comments?

Ruth says, "I have to disagree with my husband about someone only responding if they can stay at least one twelve hour shift. Now if you are responding as IS you <u>must</u> commit to twelve hours. Leaving before shift change is disruptive and unprofessional, but if you are responding as a searcher and you can only commit to 6,8 or 9 hours you can still be used. You simply must be responsible enough not to accept a task if you will have to leave halfway thur. As with anything involved in a search mission, you will be expected to be a responsible adult."

## LESSON LEARNED

Surry mission:

The subject was found in an area with a POD of 65.34%. There had been nine tasks in and around the area. In reviewing the TAF's we found that several of the tasks were done by people who were on their third task for the shift. They commented on the TAF about how tired they were. REMEMBER -Searcher efficiency drops rapidly after the first hour. Couple heat, dense foliage, swarms of bugs and the normal tiredness is increased markedly. LESSON: Don't allow people to over extend themselves. Make them take a extended rest. This is why I say normal expectations are for two four hour tasks per shift, per resource.
