But the college board didn't understand that there are group dues and individual member dues also, and it had been straightened out, just awaiting moneys. Treasurer: from the ASRC funds perspective it is not detrimental for them to pay "right now", propose to set up a payment plane to pay back past due amount on or before December 31<sup>st</sup> 2009. Maybe put PVRG on "probationary status" pending payment of current and past due amounts. To be returned to Certified B status upon payment in full? "The responsibility for submission of applications for certification and re-certification, along with associated documentation as described in the "Guide to Supporting Documentation and Process for ASRC Command and General Staff Certification Applications for ASRC", for command and general staff certifications shall rest solely with the ASRC member's Group Training Officer. All applications shall be submitted to the ASRC Training Officer no less than 30 days prior to each ASRC BOD meeting.

Reductions in certification shall occur automatically on the date when the certification expires. Exceptions to reductions in certifications shall be made on a case by case basis, upon recommendation of the ASRC Training Officer in consultation with the member's Group Training Officer and the individual ASRC member."

Administration: This motion shall be integrated into the ASRC Training Manual no less

Administration: This motion shall be integrated into the ASRC Training Manual no less than 6 months after being approved at an ASRC BOD Meeting.

6.2.1. **Background**As a result of the most recent BOD meeting, the BOD changed the emphasis of certification and re-certification placing the onus on either the BOD or an ASRC officer to remind or encourage members to submit their materials for certification or re-certification in a timely manner.

While this is generally accepted as a good practice, making this change of emphasis a rule rather than a best practice sets a dangerous precedence as a part of the governance structure for a certification system.

The emphasis of the certification should always be primarily directed toward the subject or the clients (usually law enforcement).

As a rule-making body, a certifying authority and a standards development organization, the ASRC should always build its rules with clarity and allow for the BOD to rule on variances rather than build variance into the rules.
