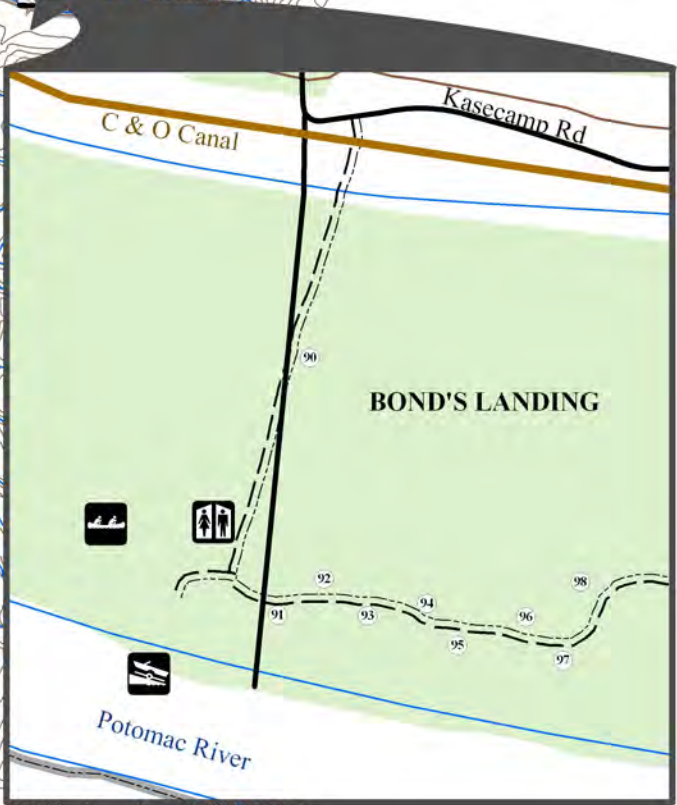
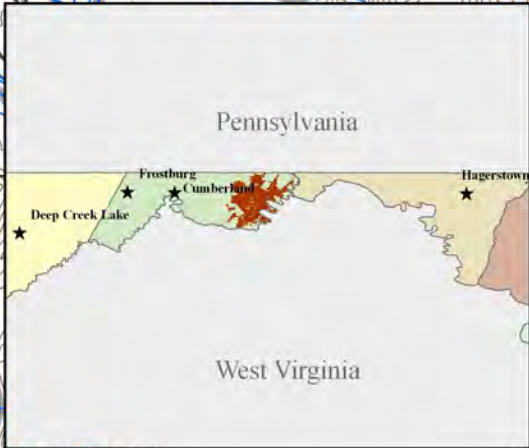
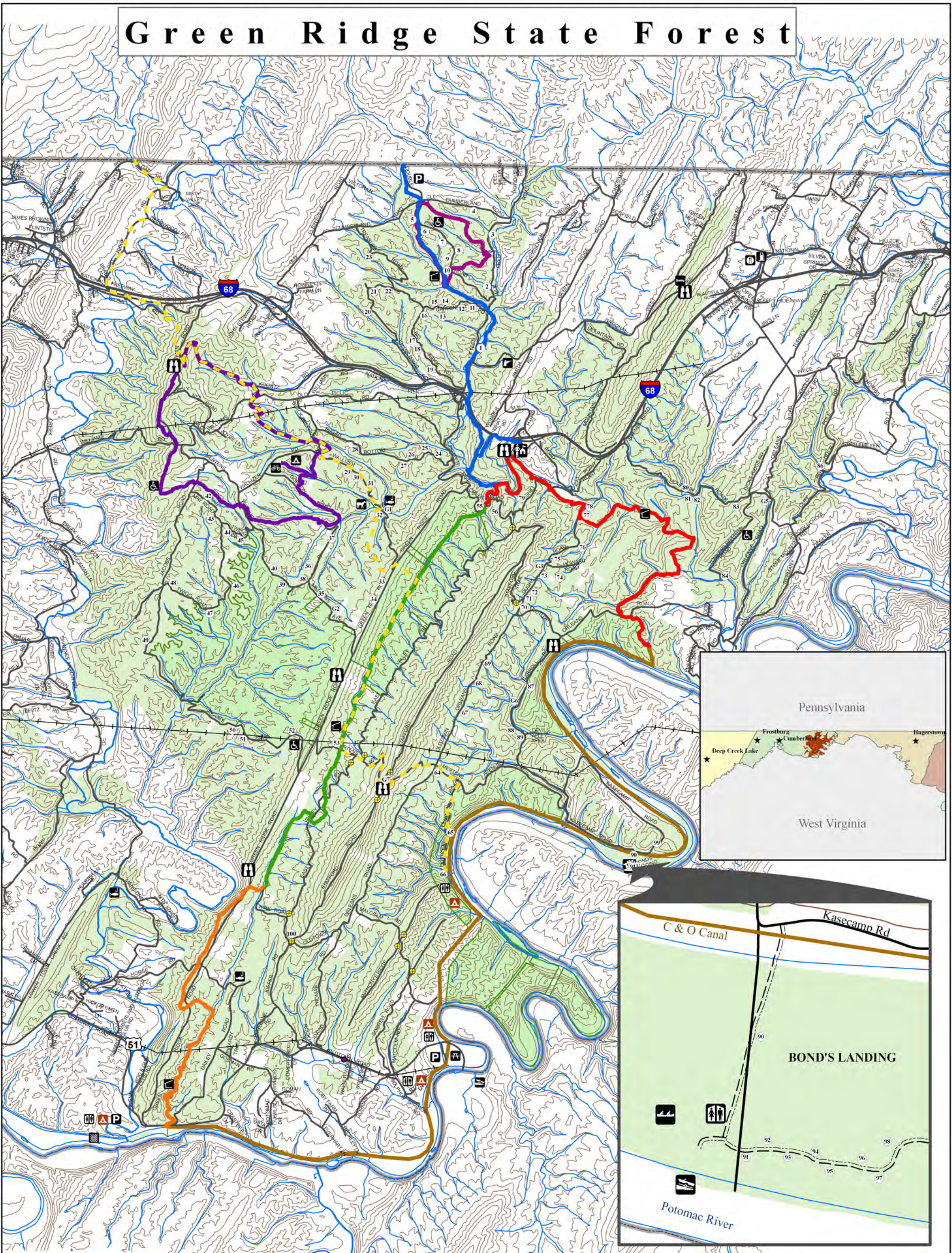
### ***--Additional Information--***
