The Challenge:

- ASRC's new Certification and Credentialing approach emphasizes demonstrated performance as the foundation of certification
- Standards (rightly) say nothing about recertification criteria
- Recertification in earlier versions of ASRC standards were based primarily on experience, which doesn't really ensure adequate demonstration of performance; all certified skills are not necessarily practiced at typical missions

The Context:

- ASRC's organizational mission is focused on sending trained and certified personnel to wilderness search incidents
- Group-based training and certification requires significant contributions from certified members

"Hybrid" Recertification

Guiding Principles



<u>The Proposed Solution—A "Hybrid" PTB</u>:

- Some skills and knowledge need to be demonstrated in a PTB
 - Rarely used skills need to be demonstrated (or taught)
 - Written testing will ensure currency of knowledge, especially knowledge of up-to-date SAR Ops best practices, jargon, etc.
- Mix of mission experience and instruction fulfill remaining recertification requirements
- Fulfillment of medical requirements (group training or FA requirement) follows group practice

Role of the Credentialing Board:

- Credentialing Board maintains oversight of recertification
- Assurance is progressively more critical for the higher field levels
 - To ensure field team leaders can effectively lead
 - To ensure instructors and evaluators are maintaining a high level of skill
 - More review by the Credentialing Board at higher field levels

Overview of Recertification Requirements at Different Field Certification Levels



(Level 3)

Level 3:

- Observation: Safety of others not generally dependent on field activities that have assured delivery at Level 3
- Five-year certification period
- Decertify to Level 4 (based on failure to complete recertification PTB)

PTB:

- Respond to 2 missions (1 may be a SAREX)
- Demonstrate patient packaging
- Demonstrate land nav skills
- Mix of 8 "instances" of missions or instructional support to fulfill remaining PTB requirements

Credentialing Board oversight:

- Written test
- Administrative review

Overview of Recertification Requirements at Different Field Certification Levels



(Level 2)

Level 2:

- Observation: Field leadership requirement requires greater assurance of skills
- Three-year certification period, with service as GTO extending certification for each year of service
- Decertify to Level 3, with two years to recertify at Level 3

PTB:

- Respond to 2 missions (1 may be a SAREX)
- Demonstrate patient packaging
- Demonstrate Land Nav skills
- Evaluated Field Team Leadership
- Mix of 7 "instances" of missions or instructional support to fulfill balance of PTB requirements

<u>Credentialing Board evaluation</u>:

- Written test
- Evaluation of Land Nav

Overview of Recertification Requirements at Different Field Certification Levels



(Level 1)

Level 1:

- Observation: Field leadership requirements and dependence on Level 1
 personnel for training and evaluation requires greater assurance of skills
- Three-year certification period, with service as GTO extending certification for each year of service
- Decertify to Level 2, with one year to recertify at Level 2

PTB:

- Respond to 2 missions (1 may be a SAREX)
- Demonstrate haul system rigging
- Demonstrate land nav skills
- Evaluated field team leadership task
- Require some instruction and evaluation activities
- Mix of 7 "instances" of missions or instructional support to fulfill balance of PTB requirements

Credentialing Board evaluation:

- Written test
- Evaluation of land nav and field team leadership





An "instance" of mission or instruction (Level 3)

- Response to a mission or SAREX
- Instructional support at one major group training event
- 4 PTB evaluations (for Level 3 PTBs)
- SAREX support role

An "instance" of mission or instruction (Level 2)

- Response to a mission or SAREX
- Instructional support at two major group training events
- Lead instructor for a major group training event
- 4 PTB evaluations (for Level 2 or 3 PTBs)
- SAREX support role

An "instance" of mission or instruction (Level 1)

- Response to a mission or SAREX
- Lead instructor at one major group training event
- 4 PTB evaluations (for field-level PTBs)
- SAREX designer




