Appalachian Region Teams:

The last meeting of the Appalachian Region was quite some time ago and little has come from that meeting except continued confusion regarding the status of National and some teams in the region.

At the last meeting some question regarding Allegheny Mountain Rescue were fully resolved and they returned to the fold. All persons that are current members of a fully accredited team, i.e. MSAR and AMRG, may vote. A member is defined as a person listed on the membership list that went forward with the application to MRA.

I have attached a ballot to be copied, distributed to members, and returned to the present Secretary, Peter McCabe, MRA Secretary, 11034 Berrypick Lane, Columbia, MD 21044 by January 15, 1994. The new officers will take office at the next regional meeting, scheduled for December/January.

It has become very important to the continuation of the region that a region meeting be held late in December of early January. Please let me know a date that will be good. Plan on a saturday other than Christmas or New Years.

Over the past year I have had some difficulties in performing the job of Chair for the region. I would like to be very clear: if you or someone on your team would like to chair the region I would appreciate it.
