By-Laws Changed

At a general membership meeting on August 28, following the regularly scheduled Board meeting, the ASRC membership voted to change Conference By-Laws to:

- enable other SAR-type groups and programs to become affiliate members of the ASRC; and
- offer Associate Membership to individuals who wish to contribute time or services to the ASRC or an ASRC Group but do not want to become active ASRC members.

ASRC By-Laws were also changed to enable the Chairman and Vice Chairman to be elected from among ASRC delegates while the ASRC Secretary and Treasurer may be elected from the general membership of the Conference. (In the event the elected Secretary and/or Treasurer are not members of the ASRC Board of Directors, they will automatically be appointed as non-voting members of the Board.)

And, the By-Laws were changed to enable the ASRC to publish and enforce standards of procedure in the form of an ASRC General Administrative Manual.

Mission & Vision Statements

The following are proposed ASRC Mission and Vision Statements discussed at the December 16 Board of Directors meetings in Charlottesville. Statements will be circulated to each ASRC Group for their consideration and approval.

Mission: The Appalachian Search & Rescue Conference provides, when requested, professional volunteers trained in ground search, ground search management, semi-technical rescue, technical rescue, and PSAR in Virginia, Pennsylvania, Maryland and occasionally in the mid-Atlantic region of the United States.

Vision: To save lives, the Appalachian Search & Rescue Conference will continously improve its ability to conduct search and rescue activities so that it will become the preferred volunteer SAR resource in the mid-Atlantic states.

Topo Map Prices Increase

Effective August 12, USGS prices for topo maps have increased to \$4.00 for <u>everyone</u>. Forty percent discounts, with a \$3.50 handling charge for each order mailed, are now available to commercial map dealers, non-profit organizations, and government agencies when ordering 5 or more sheets of the same title and ordered from USGS, Box 25286, Denver CO 80225.

ASRC-National Park Service Training Simulation Scheduled

A cooperative lost person training simulation with the National Park Service is tentatively scheduled for January 27-28, 1996 in Shenandoah National Park, Virginia. Other units planning to participate include dog handlers with air-scent dogs and tracking dogs from regional organizations, the air operations unit of the U.S. Park Police, and a unit from the Marine Corps. Staff/Command Recertifications

Recertifications for 8 the ASRC's 10 Incident Commanders, and 7 of the ASRC's 20 Incident Staff persons are due in January-February 1996. Notices have been mailed to those persons effected.

Training Agreement Signed

The ASRC has signed a Memorandum of Agreement (MOA) with Search and Rescue Training Associates (SARTA) for use of SARTA field team member and field team leader training texts and materials as the Conference's core FTM and FTL training material and base line reference. Copies of the MOA are enclosed for ASRC groups.

ASRC Training Committee Actions

The Conference Training Committee has recommended the following actions: (1) Members of ASRC Groups may arrange for their FTM or FTL written tests to be taken with other ASRC groups with the knowledge of their home Group's

Training Officer. It is understood that some Groups may have additional requirements for FTM and FTL, in addition to practical field evaluations, that must be satisfied in the Member's home Group. (2) The Incident Staff written test needs immediate revision. (3) Incident Staff in the recertification process need to provide a written record of their IS participation during their last certification period. Those persons without the required IS mission experience may retest with the ASRC IS test and the MSO written test, or they may choose to be reduced to FTL status. (4) Incident Staff persons whose ASRC certification expires while they are on inactive status, need to successfully pass the ASRC IS test and the Managing the Search Operation (MSO) written test. (5) Candidates for initial IS certification should successfully pass either a Practical Search Operations (PSO) course from SARTA or a Search Operations Symposium (SOS) course from the Blue Ridge Mountain Rescue Group. (6) Candidates for initial IS certification should be required to have participated as a base staff member in incident command operations in a minimum of two missions. Recommendations are being developed into motions for the February 1996 Board meeting.

ASRC Operations Issues

The ASRC Operations Manual has been in a major revision process for nearly a year. Sections of the former Ops Manual have been placed in a draft ASRC Administration Manual. Version 2.1.1. (October 1995) of the ASRC Ops Manual updates the initial revision in February 1995. Sections will cover: general information and overview; ASRC non-incident policies; Group non-incident operational policies; ASRC alerting and dispatching policies; ASRC incident policies; Group incident policies; and membership policies. The revised Ops Manual will include 13 annexes. It is anticipated the ASRC Web Page will include the Administrative Manual, the Operations Manual, and all ASRC Training Standards.

Tide-water Search and Rescue has redesignated their elected team leadership on the basis of the ICS system. □ William Henderson from Tidewater SAR was approved as an ASRC Incident Staff person at the December 16 Board meeting; The Virginia Department of Emergency Services hopes to provide at least one Ground SAR (GSAR) Institute during 1996, but funding limitations may restrict GSAR training opportunities.
